**4. First Aid Measures**

<i>Inhalation:</i>	If dust is inhaled, remove from contaminated area. Encourage patient to blow nose to ensure clear passage of breathing. If irritation or discomfort persists seek medical attention.

<b><u>5. Fire Fighting Measures</u></b>	
<i>Extinguishing media:</i>	Water spray or fog. Alcohol resistant foam. Dry chemical powder. BCF (where regulations permit). Carbon dioxide
<i>Special firefighting procedures:</i>	Alert Emergency Responders and tell them location and nature of hazard. Wear breathing apparatus plus protective gloves. Prevent, by any means available, spillage from entering drains or water course. <i>Containment</i>	Avoid all personal contact, including inhalation. Wear protective clothing when risk of exposure occurs. Use in a well-ventilated area. <i>Engineering controls</i>	<p>Local exhaust ventilation is required where solids are handled as powders or crystals; even when particulates are relatively large, a certain proportion will be powdered by mutual friction.</p> <p>Exhaust ventilation should be designed to prevent accumulation and re-circulation of particulates in the workplace.</p> <p>If in spite of local exhaust an adverse concentration of the substance in air could occur, respiratory protection should be considered. Such protection might consist of:</p> <p>(a): particle dust respirators, if necessary, combined with an absorption cartridge;</p> <p>(b): filter respirators with absorption cartridge or canister of the right type;</p> <p>(c): fresh-air hoods or masks</p> <p>Build-up of electrostatic charge on the dust particle, may be prevented by bonding and grounding.</p> <p>Powder handling equipment such as dust collectors, dryers and mills may require additional protection measures such as explosion venting.</p> <p>Air contaminants generated in the workplace possess varying "escape" velocities which, in turn, determine the "capture velocities" of fresh circulating air required to efficiently remove the contaminant.</p>
